# Highlights and news

## Selected TMT news over the past month

#### M&A


- Edenred has agreed to acquire Reward Gateway, a provider of employee engagement solutions, for \$1.4B.
- Crosspoint Capital Partners has agreed to acquire Absolute Software Corporation for \$918M in a takeprivate transaction. Absolute Software Corporation is a provider of endpoint security and data risk management solutions.
- The Carlyle Group has agreed to acquire Meopta-optika for \$750M in a take-private transaction. Meoptaoptika is a manufacturer of precision optical and optomechanical products.

#### Private placements / startup news

- xAI, a developer of an artificial intelligence platform, has received \$6.0B in funding from a group of investors including Andreessen Horowitz, Sequoia Capital, Fidelity Management & Research, and others.
- CoreWeave, specialized cloud provider for AI, has raised \$1.1B in funding led by Coatue Management. CoreWeave will use the funds to support the rapid growth of the business and expand into new geographies.
- Wayve, a developer of AI technology for automated driving, received \$1.1B in funding from Nvidia and SoftBank Group.



- Major stock indexes ended higher in May 2024. Nasdaq was up 7.2%, its biggest monthly gain since November 2023, and the S&P 500 was up 5.2%, its biggest monthly gain since February 2024.
- 14 IPOs were priced in May 2024. There have been 76 IPO pricings YTD, representing a 11.8% increase over the same period last year.
- PCE inflation rose 0.3%, lower than March but higher than February's increase.
- Silvaco Group, a provider of computer aided design software, electronic design automation software, and semiconductor intellectual property, raised \$114M on May 9 by selling 6.0M shares at \$19.00 per share.
- ZEEKR Intelligent Technology Holding, a battery electric vehicle technology and solutions company, raised \$441M on May 10 by selling 21.0M shares at \$21.00 per share.


### Macro indicators

Most major benchmarks closed lower over Memorial Day week despite a month of gains, with small-caps outperforming largecaps and value stocks holding up better than growth shares.


"Supercore" inflation, which excludes energy and housing costs from PCE services, has gained attention due to housing and rental cost dynamics. It showed a mixed trend, rising 0.3% in April, slightly lower than March but higher than February.

Subdued demand at midweek Treasury auctions raised concerns about deficit funding and yield increases, while Fed hesitancy to cut rates fueled market uncertainty. Despite this, signs of stabilizing inflation lowered yields on 10-year Treasury notes. Post-holiday, fixed income markets remained quiet, with below-average activity in high yield segments and weakness in below investment-grade bonds, leading to negative flows in high yield funds after recent gains.

The pan-European STOXX Europe 600 Index closed 1.7% higher for the month of May, but performance was impacted due to concerns over Eurozone inflation, raising uncertainty about European Central Bank policy beyond June.



#### Global indices performance, 2024 YTD and May 2024


#### Sector performance, 2024 YTD and May 2024




